#### The Lee Company:

Munger Construction recently assisted long-term client, **The Lee Company**, in reinventing a building on their campus located at **2 Pettipaug Road**, **Westbrook**, **CT**. This 27,582 square foot building has now become a centrally located meeting place on campus that serves functions spanning from employee trainings, to holding staff parties with a full catering space available.
